# **Children's Advocacy Institute**

The Children's Advocacy Institute (CAI) was founded in 1989 as part of the Center for Public Interest Law at the University of San Diego (USD) School of Law. CAI's mission is to improve the health, safety, development, and well-being of children. CAI advocates in the legislature to make the law, in the courts to interpret the law, before administrative agencies to implement the law, and before the public to educate Californians on the status of children.

CAI strives to educate policymakers about the needs of children-about their needs for economic security, adequate nutrition, health care, education, quality child care, and protection from abuse, neglect, and injury. Our goal is to ensure that children's interests are represented effectively whenever and wherever government makes policy and budget decisions.

Robert C. Fellmeth, J.D., CAI's Executive Director, is the Price Professor of Public Interest Law at the USD School of Law and founder of both CAI and the Center for Public Interest Law. Professor Fellmeth has 30 years of experience as a public interest law litigator, teacher, and scholar.

## **CAI Academic Program**

As part of the University of San Diego School of Law, CAI's academic program includes courses and clinical training of USD law students in child advocacy. CAI's academic program consists of two parts. First, the substantive course Child Rights and Remedies covers a variety of issues, such as tort issues relevant to children, principles in dependency and delinquency law, and current constitutional issues affecting children's rights.

Second, students who have completed or are taking Child Rights and Remedies are eligible to take Child Advocacy Clinic, one of the few law school programs in the nation that offers law students experience in representing children and working on policy issues vital to children's interests.

Child Advocacy Clinic offers two opportunities: (1) placement in the Dependency Section of the Public Defender's Office, assisting attorneys in the representation of minors in dependency court (the "Dependency Clinic"); or (2) work on policy or advocacy projects with CAI professional staff or leading professionals in the community (the "Policy Clinic").

## **Other CAI Activites**

#### Children's Advocates Roundtable

Established by CAI in 1990, the Roundtable is an affiliation of 175 statewide, regional, and local children's policy organizations, representing over twenty issue disciplines. The Roundtable, which is convened and chaired by CAI, provides a setting for child advocates to share resources, information, and knowledge; strategize on behalf of children; educate each other about the issues and legislation affecting children and youth; prioritize issues to minimize infighting over limited state resources historically budgeted for children's programs; and collaborate on joint projects that promote the interests of children and families.

#### Information Clearinghouse on Children

By serving as a research service for journalists, scholars, and public officials, the Clearinghouse stimulates more extensive and accurate public discussion on a range of issues affecting the health and well-being of California's children.

#### **CAI Publications**

CAI publishes the following documents: California Children's Budget, Children's Regulatory Law Reporter, Children's Legislative Report Card, CAI Annual Report, CAI NewsNotes, and Child Advocates Roundtable FAXBlasts. CAI publications have received national acclaim; for example, the National Association of Child Advocates has recognized that "the Children's Advocacy Institute's [California Children's Budget] remains the most thorough and well-researched document nationwide." #### Lawyers for Kids
