## A WELFARE REFORM QUIZ

The United States has enacted welfare reform provisions intended to move families once dependent upon Aid to Families with Dependent Children (AFDC) into work and self-sufficiency. The new program, called Temporary Aid to Needy Families (TANF), ends the entitlement of impoverished children to a safety net, cuts food stamps, bars most newly arriving legal immigrants from aid, and reduces or terminates benefits for children if their parents are unable to find jobs after a defined period of welfare assistance.

Critics of these reforms contend that the changes are driven by inaccuracies about recipients --helped by a daytime talk show parade of lurid confessors and by political demagogues. The popular stereotype is a system gone awry, with minority (mostly African-American) women becoming impregnated as unwed teens, going on the dole, and raising a new generation of gang-banger males and waiting-to-birth females.

Curious about how much is fact and how much fiction about welfare recipients and the new reforms, I reviewed the most recent data from the state Department of Social Services and other reliable sources, and present the following quiz to test whether you have become a victim of stereotypes.

The average age of a California TANF mother is: (A) 17; (B) 31; (C) 26; (D) 19.

The percentage of California TANF mothers who are unwed and under 19 years old is: (A) 61%; (B) 2%; (C) 21%; (D) 18%.
